This is a confirmation of the receipt of your application for the **NYLT** course scheduled from **June 7 to 13, 2026 at Rancho Los Mochos**, south of Livermore. We look forward to your attendance.

**Several Important reminders:**

1) There is an **ESSENTIAL Orientation Meeting** on Thursday, **May 7, 2025** at **Centerville Presbyterian Church** in Fremont from **7:30 to 8:45 PM**.

- Check-in with a short interview starts at 6:15 PM. We have close to 200 participants to process. **Please target arriving between 6:15 and 7:00 PM.**
- Please mark your calendar now for this critical meeting. Please reserve the entire evening.
- **Scouts should attend in full uniform.**

2) **We require an Annual Health and Medical Record form** for each participant, signed by a Medical Professional on page 4, after June 1, 2025 (last June) with them noting any limitations. Please assure that both parent/guardian and Scout sign page 1. Also on page 3, please review, and check as appropriate the boxes related to administration of non-prescription medications (OTC); if left unchecked, we must assume a "NO". We are attaching an example Medical showing blocks that are needed to be filled in. All Medicals will be checked at turn in against this form. Please also submit a copy of both sides of any insurance card.

- ***These are to be turned in at the May 7<sup>th</sup> Orientation, or***
- Upon arrival at Rancho Los Mochos on Sunday, June 7.
  - The preferred turn-in time is at Orientation. It saves you and us a lot of subsequent emails to assure you bring everything to NYLT.
- **DO NOT Email or Mail these forms. Emailing these forms is NOT permitted, nor is mailing or hand-delivering them to Council Office. They are turned in ONLY on May 7 at Orientation OR on June 7 at check-in for the course.**

3) **We require a head-and-shoulder photograph of you in uniform.**

- With close to 200 scouts, most of whom we have never seen, it helps us in identifying you. To date, from our first two mailings, only 42 of 150 have submitted photos.
  - **If you have NOT submitted a picture, please do so. Please submit thru: Photo Form**

- 4) We do ask that we have **two workable email addresses** for each participant: an email for the participant and a separate email for the parent/guardian. **If you have only used the same email for both scout and parent, please provide us with a second email address.**
- 5) Unit Leader Approval: All participants must have the approval of their Unit Leader in order to attend NYLT. We are blind-copying the leader you listed during registration.

**With respect to Unit Leader's approval:** They are blind-copied on this email. We ask that they ONLY respond back IF you will not be able to meet any of the above requirements. **Unit Leaders: Only respond for issues.** If everything is OK, no response is needed. We will separately provide you a consolidated list of all Scouts registered from your unit. We do expect that the scout will double-check with you to assure that they are approved.

Again, we look forward to having you on the **NYLT course at Rancho Los Mochos from June 7 to 13** and to seeing you on **May 7 for Orientation with check-in starting at 6:15 PM**. If you believe you did not register for NYLT or can no longer attend, please reply immediately to this email so that we can resolve any issues.
